#### 3. 開發智能組串式構網型儲能技術，消納清潔電力

我們依托三塘湖新能源電站配套儲能項目，開展「100MWh級智能組串式構網型儲能系統」的研發工作。該系統可以通過模擬同步發電機的方式，為電力系統提供慣量、頻率和電壓支撐，從而增強電力系統穩定性，使電網能更好地消納清潔電力。2024年12月，項目成功完成試驗，標誌著其具備正式運行條件，可以為電網提供長期、穩定的支撐。2025年1月，該項目榮登國家能源局第四批能源領域首臺(套)重大技術裝備名單。

#### 4. 聚焦香港綠色交通替代，聯動內地多場景示範項目

我們深度參與香港綠色交通替代進程，堅持「深耕一個市場，依靠一個團隊，搭建一個體系，使用一套標準，提供一流服務，成就一個品牌」的「六個一」思路，積極構建充電業務核心競爭力，推動充電網絡互聯互通；同時輻射內地，打造蘇南經開區充電網、重慶光儲超充網、廣州南沙徐工重卡換電站、焦作高鐵站光儲充等多業務場景示範項目，累計已投運集中式公共充電站114個，充電終端2059個，總充電功率65MW。

#### 5. 電能聚合+碳能聚合，豐富綜合能源服務

我們錨定「成為一流的清潔能源供應商和綜合能源服務商」的願景，以「電能聚合+碳能聚合」為發展方向，聚焦「三電一節能」重點賽道，強化運營管理體系建設與新技術迭代升級，研發低碳節能標準化產品，全力拓展綜合能源業務。

### 1.廢氣

引入先進技術與設備，全面升級燃煤發電機組脫硫、脫硝、除塵系統。河北區域火電機組先行先試，達到省環保績效A級標準，煙塵排放濃度小於5毫克/立方米，二氧化硫排放濃度小於25毫克/立方米，氮氧化物排放濃度小於30毫克/立方米。

### 2.廢水

華潤電力著力推進水資源循環利用，強化梯級利用與廢水回用效率，持續擴大城市再生水應用規模，旗下磴口、盤錦、豐潤等11家火力發電廠使用城市再生水替代新鮮水源；錫林郭勒項目協同回收利用礦井疏幹水每年約4萬噸，節約等量新鮮用水。


### 3.廢棄物

我們嚴格落實《中華人民共和國固體廢物污染環境防治法》的要求，提升危險廢物的管理水平，推動無害廢棄物綜合利用，有效降低固體廢棄物對環境的潛在威脅。2025年1-10月，公司深汕、廣州、板橋等9家燃煤電廠累計協同處置4市政汙泥68.87萬噸；古城電廠協同處置藥渣（危險廢棄物）13·518.24萬噸；焦作電廠協同處置廢電石渣15·790.54萬噸；賀州電廠協同處置廢大理石漿液97·800.98萬噸；錦州電廠協同處置白泥19·921萬噸。

## 三、投身低碳與環保技術創新應用，助力溫室氣體減排。

### 1. 聚焦綠色低碳技術

我們持續投入CCUS技術研發工作，為我國推進實現「雙碳」目標貢獻力量。我們基於深汕公司2萬噸/年多線程碳捕集平臺，申請「用於二氧化碳吸收劑再生的高效催化材料及外場強化技術項目」與「基於煤/生物質耦合燃燒高效清潔發電負碳排放關鍵技術」兩個國家重點研發計劃項目，主導編寫「燃煤電廠煙氣碳捕集裝置技術監督導則化學吸收法」中國電機工程學會團體標準，發明的「一種碳捕集後廢氣中有機胺濃度的測量裝置及測量方法」申請專利並被受理。


